Our assurance to you regarding your pre-paid fees	We are committed to delivering quality education and training. Under the Standards, we, as an RTO, are required to have systems in place for ensuring the quality and validity of training and assessment throughout the scope of registration and across all modes of delivery. The Standards require RTOs to comply with an acceptable option when collecting student fees in advance. EQC charges per unit of competency in line with our requirements and does not charge more than 30% up front of the Co-Contribution Fee payable by you as a student. Fees per delivery model	EQC Institute offers 2 course types in Queensland: Bootcamp or Self-Paced Online formats. The fees are stated below for both: Bootcamp: Eligibility: You will be vetted for entry into this course, to check that it is the correct course format for you. This course is intensive and fast paced. Our total course fee is \$5,220. This course is available as a Queensland Government subsidised course, subject to meeting eligibility requirements. (See our website for details) - If you are a Non-Concession holder the Queensland Government will subsidise \$3,730 of the course fee. - If you are a Queensland Concession holder the Queensland Government will subsidise \$4,849 of the course fee. The Queensland Government requires you to pay a Co-Contribution Fee. The Co-Contribution Fee set by EQC Institute for this course is: - Co-Contribution Fee (Non Concession): \$1,490 - Co-Contribution Fee (Concession Holder): \$371 Self-Paced Online: This course utilises our state of the art and custom built EQC Learning Hub. You attend virtual classes and complete work in a self-paced environment with support from your designated EQC Training Team member. Our total course fee is \$7,800 This course is available as a Queensland Government subsidised course, subject to meeting eligibility requirements. (See our website for details) - If you are a Non-Concession holder the QLD Government will subsidise \$3,730 of the course fee. - If you are a Queensland Concession holder the QLD Government will subsidise \$4,849 of the course fee The Queensland Government requires you to pay a Co-Contribution Fee. The Co-Contribution Fee set by EQC Institute for this course is: - Co-Contribution Fee (Non Concession): \$4,070 - Co-Contribution Fee (Concession Holder): \$2,951
Eligibility	To be eligible for Queensland Government subsidised training, you must meet the criteria set out by the Queensland Government. To be eligible you must be: - 15 years of age or older; - Not a school student; - A Queensland resident; - An Australian citizen, permanent resident (PR) (including humanitarian visa), on a proper pathway to PR, or a New Zealand citizen; - Not enrolled in any other qualification whether funded or unfunded except foundation skills; and Meet the additional requirements for the particular Queensland subsidised training program, being Careers Boost: - Not have completed a qualification that is Certificate IV or higher in the last ten years (unless commenced at school); and - Not have exceeded the Careers Boost limit of subsidised places per person - one training place in one qualification or traineeship and two skill sets per person.

Surveys	You will be asked by the Queensland Government to complete a survey of your experience in undertaking this course, as well as your training goals and outcomes, which is part of assessing the impact of this Queensland Government subsidised training initiative. Concessions	To be eligible for a concession Co-Contribution Fee, a student must meet one of the following: - Hold a health-care, veteran or pensioner concession card issued under Commonwealth law, or be the partner or a dependant of a person who holds such a card and is named on the card; - Hold an official form issued under Commonwealth law confirming that they, their partner or the person of whom they are a dependant is entitled to concessions under a Health Care, Veteran or Pensioner Concession Card; - Identify as Aboriginal or Torres Strait Islander; - Have a disability; - Be an adult prisoner.
Refunds and 'cooling off'	The Queensland regulatory framework governing subsidised training in the state requires all Queensland approved providers (of which EQC is one) to not refund, waive, return payment or provide a cash payment or bonus by way of "referral fee" or otherwise to any payer of the Co-Contribution Fee (including third parties) unless one of the circumstances described below applies. A refund of the Co-Contribution Fee may be issued if one of the following limited exceptions applies: - The training has not commenced at the time of enrolment cancellation, in which case a full refund of the Co-Contribution Fee shall be issued to the payer of that fee; and - If a student withdraws from a Unit of Competency or module, in which case a proportionate refund applies in respect of the unit or module withdrawn from. If one of the above exceptions applies, you may apply for a refund by submitting a Cancellation Request Form. In a case of extreme hardship, you should submit a Special Consideration Request Form. These forms are available for download from our website. Further details on fees, charges and refunds are set out in our Fees, Charges and Refunds Policy and Procedure, and the Queensland Subsidised Training Fees, Charges and Refunds Addendum.
Study in Australia as a domestic student	To study a domestic course, you must be an Australian permanent resident or in Australia on a visa that permits study for the duration of your course. - If you are not a permanent resident and are on a visa, call our Team to check enrolment options open to you, as subsidised training may not be available, under government conditions. - If you are or intend to be an international student in Australia (on a Student Visa) or if you wish to study offshore, please call our Team to obtain information about enrolment options applicable to you.
